Motorplex is furnishing the undersigned customer with a rental car for his/her convenience while his/her vehicle is being repaired. Customer represents and warrants that he/she has a valid policy of automobile liability, collision, and comprehensive insurance in force at time of the execution of this rental agreement that will cover this rental car, and further represents and warrants that he/she shall maintain said policy of automobile insurance in force during the time that the subject vehicle is in his/her care, custody, and control. **MOTORPLEX relying on said warranty and representation, is not providing automobile liability, collision, comprehensive and/or medical insurance to the customer or any person operating, using, or otherwise occupying subject vehicle.**

**Renter accepts full responsibility for any and all damages to subject vehicle regardless of fault.** Any payment due hereunder shall be due and payable, in full, at the time the customer picks up his/her vehicle from repairs.

Should it be necessary for MOTORPLEX to retain an attorney to collect for any damage suffered by it as a result of customer's operation of the rental car, customer agrees to pay all costs of collection, including attorney's fees, incurred by MOTORPLEX.

### RENTAL CAR REQUIREMENTS & TERMS:

- \_\_\_\_\_ Cost of rental car is \$\_\_\_\_\_ per day plus applicable taxes and is charged per 24 hour period. Any additional hours will be charged on a prorated basis.
- \_\_\_\_\_ A damage deposit of \$1000 is required. Credit card imprint is required.
- \_\_\_\_\_ Rental car must be returned within 12 hours of notification of completion of repairs on customer's vehicle. Daily charge beyond this 12 hour grace period is charged at a rate of \$75 per day plus applicable taxes.
- \_\_\_\_\_ Car must only be driven within a 50 mile radius of Motorplex unless otherwise permitted in writing by Motorplex.
- \_\_\_\_\_ Rental includes mileage of up to 100 miles per 24 hour rental. \$.75 cents per mile to be charged for each mile greater than 100 per 24 hour rental.
- \_\_\_\_\_ Vehicle must be returned with as much or more fuel than what was in it upon acceptance of vehicle, and that any less fuel will be charged at \$5.00 per gallon.

**Motorplex Rental Car Rules and Fees:**

- 1. Have a valid Washington State driver license for at least one year
- 2. Must be 21 years of age or older
- 3. Have provided us a driving record that meets the following requirements (Fee to Obtain is \$13.00):
  - a. No more than two incidents (moving violations or accidents) in the past three years and no more than one in the last 18 months.
  - b. Have had no major violations in the past three years.
  - c. Have had no alcohol or drug related violations in the past seven years.
- 4. When applicable, a cleaning fee will be charged at a rate of \$95.00 per hour with a minimum of 1 hour.
- 5. Any accidents, dents, or scratches that remove paint or cannot be washed off, will be charged at actual cost and will be repaired at Westover Auto Rebuild or Auburn Collision Center. You are responsible for paying 100% of the actual cost either by means of your insurance or paid directly by you.
- 6. Tire repair or road hazards will be charged at actual cost of repair.
- 7. Windshield chips or damages will be charged at actual cost of repair.
- 8. Fuel used and not replaced by customer will be charged at \$5.00 per gallon.
- 9. Loss of key will be charged at actual cost of replacement.
- 10. Locking keys in vehicle will be charged \$74.00 for a service call.
- 11. Leaving lights on and needing a jump start will be charged \$74.00 for a service call.
